

Your privacy is important to us. Photographie d'événements Mélissa Vincelli is committed to respect your privacy through the protection of your Personal Information. The mvphotographer.ca Privacy Policy is intended to explain what we do with your information, and what you can expect from mvphotographer.ca. Mvphotographer.ca may update this policy from time to time.

### **Types of Information Collected**

Mvphotographer.ca gathers only the customer information that we need to administer our business and to provide superior services. The following outlines our pledge to you:

- Purpose and Consent: Before collecting your Personal Information, or at the time of collection, we will explain to you the purpose of collecting it and obtain your consent.
- Limiting Collection: Our collection of Personal Information is limited to what is reasonable under the circumstances and your information will be used only for the purpose for which it is collected.
- Security: Your Personal Information is kept confidential and secure and is not disclosed to anyone outside our company without your consent, unless required by law.
- Access: You have the right to access your own Personal Information, and to correct any inaccuracies.

There are two categories of information we may collect about you when you visit our site. We collect your name, telephone number, and email address when you use the contact form. This information enables us to contact you if needed. We also collect your name and email address when you sign up for our email newsletter regarding offers or promotions. Subscribers have the option of withdrawing consent at any time by clicking the unsubscribe link in the email newsletter. Your Personal Information may also be used to create statistics about our business. These statistics would not contain any information that could identify you personally.

The second category is non-personally identifiable information. Data, such as your IP address, browser type, browser language, the city and region related to your IP address, and specific web pages through which you click, is gathered in order to gain a better understanding of site development needs. This data is collected automatically and utilized in aggregate to help us look for trends so that we can improve our web site and your user experience.

### **Using Cookies**

"Cookies" are small pieces of information that are stored by the browser on your hard drive. Mvphotographer.ca may store some information on the visitor's computer in the form of a cookie or similar file. The cookies that are configured by us do not contain any personally identifying information, such as your name, or sensitive information, such as your credit card number. The cookies allow us to know how you navigate on our site without relating this information to any identifiable individual.

### **Disabling Cookies**

Most web browsers allow you to exercise control over cookie files on your computer by erasing them, blocking them, or notifying you when such a file is stored. Please take a look at your particular browser for instructions on this function. If you do elect to disable a mvphotographer.ca cookie, please note that you may not be able to take full advantage of a personalized experience.
